B2-TOURIST VISA - CHECKLIST		Yes	No
1	Online Visa Application form for tourist visa completely filled and signed by the applicant. <b>(01 application form per person)* Previous passport need to be submitted</b>		
2	Two Recent (not older than six months) size photographs in color with white background. (5.5cm / 5.5cm). <b>Please do NOT staple.</b>		
3	The Passport should be valid for at least six months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Israel territory and with at least one blank page to affix the visa.		
4	A covering letter from the applicant introducing himself/herself, explaining the purpose, duration & itinerary of the visit in brief and details of expenses.		
5	Leave letter from employer / school stating dates of travel/ No-Objection Certificate is required. <b>Along with 4 months' salary slip</b>		
6	<b>If invited by a friend or relative then an invitation letter form the invitee is required (in Hebrew or English) with the following details.</b> <ul style="list-style-type: none"> <li>- <b>Name of the applicant</b></li> <li>- <b>Passport number of applicant</b></li> <li>- <b>Purpose of visit and duration of stay</b></li> <li>- <b>Details of Expenses</b></li> <li>- <b>Stamp and Signature</b></li> </ul>		
7	<b>Proof of funds for stay / Evidence of source of Financial support such as :</b>		
(a)	Personal Bank statement of the applicant for last 4 months in original (Name of the applicant should be certified by the bank in the statement) -- Statement downloaded from the internet will NOT be accepted.		
8	Proof of purpose of the visit: evidence of accommodation, e.g. confirmed hotel reservation or confirmation of organized tour, if staying at friends or relatives place then passport scan copy of the invitee is required.		
9	Travel ticket booking		
	<b>Overseas travel medical insurance</b> valid for Israel. The insurance has to cover the applicant for at least 40,000 US\$ or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure		
10	<b>. Day to day itinerary from the tour operator in Israel</b>		
11	One Photocopy set of all documents which is mention in Checklist		

**A. If spouse is accompanying and spouse name is not endorsed on the passport then original marriage certificate with *APOSTILLE* from the Ministry of External Affairs, Patiala House is required, if minor is traveling with or without parents then parents will have to visit Consulate for signing declaration.**

**B. All documents should be in A4 size and not in back to back format. Further,** applicant could be asked for additional documents by The Embassy / Consulate General of Israel.
